
WITHDRAWAL OF LEGAL SERVICES

This leaflet sets out the reasons why legal services might be withdrawn and the procedures applied by the Legal Aid Board where the withdrawal of legal services is an issue.

Withdrawal of legal services

If I am granted legal advice why might it be withdrawn?

The Board may cease to provide legal advice where it considers that:

- it is no longer reasonable for you to continue receiving it; or
- because of any unreasonable behaviour by you, having regard to the particular circumstances of the case.

Withdrawal of legal aid

The Board may withdraw legal aid either by revoking or terminating the legal aid certificate granted to you.

If I have been granted a legal aid certificate can it then be revoked?

The Board may **revoke your** legal aid certificate where:

- you have made an untrue statement as to your income or capital resources in your application for legal aid; or
- · you have failed to disclose any material fact.

If your legal aid certificate is revoked, you will be responsible for the costs incurred by the Board in providing you with legal services.

If I have been granted a legal aid certificate can it be then be terminated?

The Board may **terminate** a legal aid certificate where, for example:

- you are more than 21 days overdue in paying your contribution;
- you have not complied with a condition attached to a certificate;
- you are no longer eligible for legal aid on financial grounds; or
- the Board considers that you are behaving unreasonably.

Stages in the withdrawal of legal services

What happens if legal services are to be withdrawn from me?

There are **four** stages involved in the withdrawal of legal services, as follows:

- 1. the Board forms the **intention** to withdraw legal services;
- 2. the Board makes a **decision** to withdraw legal services;
- 3. you may seek to **review** a decision; and
- 4. you may appeal a decision.

When an **intention to withdraw** legal services has been formed, your solicitor will generally be asked not to do any further work on your behalf.

Procedure for withdrawal of legal services

Stage 1 Intention to withdraw legal services

When the Board forms an intention to withdraw legal services, it will:

- let you know in writing, either directly or through your solicitor;
- advise you of the reason(s) for the withdrawal of legal services; and
- advise you of the right to give reasons as to why legal services should not be withdrawn.

The Board will consider any submissions made by you, or made on your behalf **before** making a decision on the withdrawal of legal services.

Stage 2 Decision to withdraw legal services

When the Board decides to withdraw legal services, it will let you know in writing, either directly or through your solicitor, of:

- the decision:
- the reason(s) for the decision; and
- your right to have the decision reviewed and/or appealed.

Stage 3 Review of a decision

When is the review procedure used?

The review procedure should be used if there is further information available that is relevant to the Board's decision.

What must you do if you want a review of a decision?

If you wish to seek a review of a decision you must give any extra relevant information within one month of being told about the decision, either directly to the Board or through your solicitor.

If, on review, the Board agrees with the first decision, you will be notified in writing of:

- the decision;
- the reason(s) for the decision; and
- your right to appeal the decision to an appeal committee of the Board.

Stage 4 Appeal a decision

How can I appeal a decision?

You may appeal a decision of the Board, either:

- · through your solicitor, or
- by writing directly to the Board.

Any such appeal must be made within one month of the notification of the decision.

Who will tell me the outcome of my appeal?

An appeal committee will make a decision. The Board's Head Office will inform you in writing, either directly or through your solicitor, of the decision.

If the appeal committee decides that you should continue to receive legal services, such services will start again immediately.
